Explanation of Responses:

- The number of shares shown represents the portion of the December 2006 performance-related restricted stock units (PBRUs) that vested and were paid on February 26, 2008. These PBRUs were awarded in December 2006, as described below in footnote 4.
- Each restricted stock unit represents a contingent right to receive the value of one share of A. H. Belo Corporation Series A Common Stock. RSUs are valued as of the date of vesting and are paid 60% in shares of A. H. Belo Corporation Series A Common Stock and 40% in cash.
- The number of shares shown represents the settlement of the 40% cash portion of PBRUs that vested and were paid on February 26, 2008. Settlement of the cash portion is, pursuant to SEC guidance, deemed to be a sale of shares to the Company.
- These PBRUs were awarded in December 2006. The actual number of PBRUs earned was determined on February 26, 2008.
- One-third of these PBRUs vests and is paid out as soon as practicable following each annual earnings release date for the fiscal years ending December 31, 2007, 2008, and 2009. Earned PBRUs not yet paid are subject to additional vesting requirements that depend on the continued employment of the reporting person with the Company.
