Explanation of Responses:

- Effective December 10, 2018, the Board of Directors of the Company accelerated the vesting of all outstanding time-based restricted stock units (TBRUSUs) held by the Reporting Person and converted the payment of each TBRUSU into the right to receive cash in an amount equal to the closing market price of a share of the Company's Series A Common Stock on the New York Stock Exchange on December 10, 2018. The number of shares shown represents the TBRUSUs that vested on December 10, 2018 and will be paid 100% in cash on December 11, 2019.
- Each TBRUSU represented the right to receive the cash value of one share of A. H. Belo Corporation Series A Common Stock on the vesting date. Upon vesting, no additional purchase price was payable by the Reporting Person.
- The number of shares shown represents the settlement, 100% in cash, of TBRUSUs that vested on December 10, 2018 and will be paid on December 11, 2019. Pursuant to SEC guidance, settlement in cash is deemed to be a disposition of shares to the Company.
- These TBRUSUs were awarded on May 12, 2016.
- These TBRUSUs were awarded on May 11, 2017.
- These TBRUSUs were awarded on June 6, 2018.
